**SUMMARY:** Notice is hereby given that the Rural Development, (RD) as required by the National Environmental Policy Act, is issuing an environmental assessment (EA) in connection with possible impacts related to a project proposed by the Kent County MD. Department of Public Works, 729 Morgnec Road, Chestertown MD 21620. The proposal is for construction of a Groundwater Treatment Facility. The Kent County Department of Public Works has submitted an application to the RUS for funding of the proposal.

**SUPPLEMENTARY INFORMATION:** The Kent County Department of Public Works proposes to construct a groundwater treatment facility.

McCrone Engineering, an engineering and environmental consultant, prepared an Environmental Assessment for the RUS program that describes the project, assesses the proposed project's environmental impacts, and summarizes as applicable any mitigation measures used to minimize environmental effects. The RD Program has conducted an independent evaluation of the environmental assessment and believes that it accurately assesses the impacts of the proposed project. No significant impacts are expected as a result of the construction of the project.



A general location map of the proposal is shown below.


## Exhibit 1 - Study Area
