# Welcome/Introductions - Jennifer McCready, Director of Community Addictions Services

William Webb, Health Officer - KCHD - Focus today will be on the Opioid Restitution Grant Fund.

**Carla Thorpe, Director - A.F. Whitsitt Center -** New initiative at the Whitsitt Center "Transportation to Treatment". 8 individuals have utilized transportation to treatment, thus far. RIM has been helping to support this effort.

#### Katie Dilley - Mid Shore Behavioral Health -

- Katie announced that Kate Dulin, CPRS, RPS has joined MSBH as Behavioral Health Coordinator Harm Reduction Lead. The team at MSBH is very excited to have Kate on board!
- SORIV Awards: A reminder to the group of the importance of referring to the SORIV Crisis Beds as they have moved into a fee for service reimbursement model. MSBH is working to finalize contracts with all SORIV recipients.
- A.F. Whitsitt: MSBH and the leadership team at the KCHD have been working to collaborate
  on a possible pilot model for diversion from detention with the utilization of A.F. Whitsitt Center
  beds. This will be a pilot with Kent and Queen Anne's counties. This is in the formative and
  planning phase. Any updates will be brought to the LDAAC.
- Assisted Outpatient Treatment (AOT): MSBH is collaborating to host two regional stakeholder meetings to discuss the AOT implementation planning and possible endorsement for a regional model to include Cecil, mid-shore, and Wicomico counties. The meetings are planned for 12/5 at 9:00am and 12/18 at 2:00pm. All interested parties are welcome!

**Melanie D. Jones-Dalziel - MDH - State Care Coordination/Overdose Fatality Review(OFR)** 7 enrolled in State Care Coordination, 4 went to recovery houses. Completed 4 MDRN applications. **Chief Ronald Dixon - Law Enforcement** - 1 new officer in CIT training. 341 pounds have been collected in Drop boxes.

**Christina Russell - DHS - START -** Currently there are still 5 START cases. START is still in the progress of being a START Certified site.

**Annette Duckery - MDH - Prevention -** Fallfest at Lockbriars had approximately 300 attendees. Letter of intent submitted for the Marijuana Grant. "Don't Share Leftovers" campaign to promote 3 medication dropboxes. Red Ribbon Week was held at the KCMS with help from RIM. December 13th, Santa's Workshop with Parks and Rec at the Rec Center. December 20th, Math & Magic at Kent County Middle School.
