William Webb, Health Officer - KCHD - Special Secretary Emily Keller from the Maryland Office of Overdose Response was in Kent County at the RIM Center on September 25th, and was well received. Thanks to everyone who was able to participate.

September was Going Purple month, thanks to all who participated and helped raise awareness about the risk of overdose and opioid addiction.

Carla Thorpe, Director - A.F. Whitsitt Center - SOR III crisis bed grant ended on September 29th. Notification was received that SOR IV has been approved. Recruitment efforts are underway to bring on a certified peer, direct care staff, and weekend RN's and LPN's. Job information can be found on the Maryland State website.

On Sunday, September 29th, A.F. Whitsitt Center held their Annual Alumni Event. Jennifer McCready was this year's "Friend of Recovery" award recipient. This award is in honor of Dr. Whitsitt who had the foresight to know that people with alcohol use disorders needed some place to go here in our region.

Melanie D. Jones-Dalziel - MDH - State Care Coordination/Overdose Fatality Review(OFR) 10 enrolled in State Care Coordination, 5 went to recovery houses. Completed 3 MDRN applications.

Brett C. Forest - MDH - RIM/OPT/NHIH - On October 7th, Outreach will be in Rock Hall. October 13th we'll be at the Rock Hall Volunteer Fire Department for Wellness Fair, from 10am to 2pm. Monday, October 21st, Outreach will be in Millington. October 24th, there will be a Pumpkin Carving event at the RIM Center from 4pm to 6pm. Pumpkins will be supplied by Lockbriar, Acme, and Redners. October 31, we will be at Social Services for Trunk or Treat. Men's Group is on Wednesday's from 5pm to 6pm and Women's Group is Thursday's, 5pm to 6pm.

Chief Ronald Dixon - Chestertown Police - One of our officers will attend a week long crisis intervention team training in October. It is an intensive training that deals with mental health and substance abuse.

Nikki Strong - DHS - START - On-site review was held in September and all went well. Currently there are 4 START cases. Cassandra Richardson, our PEER Mentor has been chosen to do a national speech at a conference in DC. October 31st, is Trunk or Treat at DSS. Anyone who would like to have their vehicle there, please call Kent County DSS. There are two positions available, Adult Services Worker and a Child Protective Services Worker.

Rosemary Ramsey Granillo - Kent County LMB - We are actively canvassing our community for needs assessment. There are 5 local Canvassers. They have knocked on over a 1000 doors. 200 direct interviews with residents around Chestertown and a few outside of town. We are asking them what they would like to see in their neighborhood for children and families in the community.

Annette Duckery - MDH - Prevention - Approved to continue the partnership for the responsible beverage server training, called Servsafe. 40 Kent County participants have been trained. Alcohol education and prescription drug safety classes have been prepared for the schools. The Christian Academy will be using the course for their health classes.

Assemblies were held at the high school and middle school. "Dirt", a performance by John Morello, about growing up and mental health. An interview with Mr. Morello followed at the local radio station.

Upcoming: Fall Festival at Lockbriar Farms on November 2, 10am to 4pm in partnership with Parks and Recreation and KCHD Tobacco Prevention.
