- 3. ALL MARINA SLIPHOLDERS HAVE BEEN MADE AWARE OF THE PROJECT AND HAVE BEEN ADVISED THAT THEY WILL BE REQUIRED TO VACATE ALL SLIPS WITH APPROXIMATELY ONE WEEK NOTICE FROM START OF WORK. IT IS THE INTENT OF THIS PROJECT TO TURNOVER THE COMPLETE WORK AREA TO THE CONTRACTOR AT ONE TIME, AND NOT DEMOLISH OR CONSTRUCT THE PROJECT IN STAGES/PHASES BY AREA.
- 4. The limits of work overlap a federal channel. Though there is no time-of-year restriction for this project, copies of the project permits have been enclosed herein for general reference. All project work shall be in compliance with the enclosed permits, which are formally incorporated into the project RFP documents by copy of this addendum.

All timber test piles shall meet the requirements of ASTM D25 for Round Timber Piles, and shall be 13"-3' Butt, 8" min, tip. Test Piles shall be performed by Drop Hammer.

PURSUANT TO THE AUTHORITY OF THE BOARD OF PUBLIC WORKS, TITLE 16 OF THE ENVIRONMENT ARTICLE, ANNOTATED CODE OF MARYLAND, AND CODE OF MARYLAND REGULATIONS 26.24 AND 23.02.04, **Kent County Dept of Public Works** ("LICENSEE") IS AUTHORIZED BY THE WATER AND SCIENCE ADMINISTRATION ("ADMINISTRATION") TO CONDUCT THE FOLLOWING REGULATED ACTIVITY IN STATE TIDAL WETLANDS, IN ACCORDANCE WITH THE CONDITIONS OF THIS LICENSE AND THE ATTACHED PLANS DATED **February 1, 2023**, PREPARED BY **Davis, Bowen & Friedel, Inc,** AND APPROVED BY THE ADMINISTRATION'S TIDAL WETLANDS DIVISION ON **April 28, 2023**, AND INCORPORATED HEREIN:

1. Dock "A":

- a. Remove existing finger piers and associated structures.
- b. Construct four 18-foot long by 3-foot wide finger piers and twelve mooring piles, all extending a maximum of 39 feet channelward of the mean high water line.

2. <u>Dock "B"</u>:

- a. Remove an existing pier and associated structures.
- b. Construct a 131-foot long by 6-foot wide timber pier, a 15-foot long by 3-foot wide finger pier, an 18-foot long by 3-foot wide finger pier, two 25-foot long by 3-foot wide finger piers, and fourteen mooring piles, all extending a maximum of 169 feet channelward of the mean high water line.

3. <u>Dock "C":</u>

- a. Remove an existing pier and associated structures.
- b. Construct a 150-foot long by 8-foot wide timber pier, three 16-foot long by 3-foot wide finger piers, a 20-foot long by 3-foot wide finger pier, and seventeen mooring piles, all extending a maximum of 134 feet channelward of the mean high water line.

4. **Dock** "D":

- a. Remove an existing pier and associated structures.
- b. Construct a 31-foot long by 6-foot wide timber pier, five 15-foot long by 3-foot wide finger piers, three 25-foot long by 3-foot wide finger piers, and twenty five mooring piles, all extending a maximum of 50 feet channelward of the mean high water line.
- 5. Construct and backfill 725 linear feet of replacement timber bulkhead within a maximum of 18 inches channelward of the mean high water line.

SPECIAL CONDITIONS

- A. The Licensee shall assure that there is no discharge of sanitary wastewater from any boat or vessel moored, berthed, or docked at this mooring or docking facility, except as prescribed by federal or State regulations.
- B. The Licensee shall assure that boat maintenance areas on dry land shall be designed and operated so that residues from bottom scraping, painting, or other discharges and spills associated with required boat maintenance do not enter the waters of the State. Toxic materials shall be properly stored and handled.
- C. The Licensee shall assure that all boat maintenance at individual slips shall be restricted to those activities that can be performed without materials entering the waterway.

GENERAL CONDITIONS

- A. The Maryland Department of the Environment has determined that the proposed activities comply with, and will be conducted in a manner consistent with the State's Coastal Zone Management Program, as required by Section 307 of the Federal Coastal Zone Management Act of 1972, as amended.
- B. The Licensee shall comply with all Critical Area requirements and obtain all necessary authorizations from local jurisdiction. This License does not constitute authorization for disturbance in the 100-foot Critical Area Buffer. "Disturbance" in the Buffer means clearing, grading, construction activities, or removal of any size of tree or vegetation. Any anticipated Buffer disturbance requires prior written approval, before commencement of land disturbing activity, from local jurisdiction in the form of a Buffer Management Plan.
- C. If the authorized work is not performed by the property owner, all work performed under this Tidal Wetlands License shall be conducted by a marine contractor licensed by the Marine Contractors Licensing Board (MCLB) in accordance with Title 17 of the Environment Article of Annotated Code of Maryland. A list of licensed marine contractors may be obtained by contacting the MCLB at 410-537- 3249, by e-mail at MDE.MCLB@maryland.gov or by accessing the Maryland Department of the Environment, Environmental Boards webpage.
- D. The Licensee certifies real property interest in the contiguous upland.
- E. The issuance of this permit is not a validation or authorization by the Department for any of the existing structures depicted on the plan sheets on the subject property that is not part of the authorized work description, nor does it relieve the Licensee of the obligation to resolve any existing noncompliant structures and activities within tidal wetlands.
- F. This License does not authorize any existing structures depicted on the plan sheets that are not specifically described in the description of work.

- G. The Licensee acknowledges that this authorization is based on current water depths that are existing and indicated on the attached plan sheet. This License proposes no dredging and this license provides no justification or assurances for future dredging. All dredging projects will be evaluated on the biological and physical characteristics of the site at the time an application is made.
- H. The Licensee shall obtain an approved sediment and erosion control plan from the local soil conservation district when the area disturbed is greater than 5000 square feet or 100 cubic yards of fill.
- I. The Licensee shall ensure that a copy of this License, including the approved plans, is available at the site until the authorized work is complete.
- J. The Licensee shall make every reasonable effort to design and construct the structure or perform the activity authorized in this License in a manner which minimizes adverse impacts on natural resource values, including water quality, plants, wildlife, plant and wildlife habitat, and on historic property values.
- K. The Secretary of the Environment may suspend or revoke a License if the Secretary finds that the Licensee has not complied with any condition or limitation in the License or has exceeded the scope of the authorized activities.
- L. The Licensee shall indemnify, defend and hold harmless the State of Maryland, its officials, officers, and employees from and against any and all liability, suits, claims and actions of whatever kind, caused by or arising from the work authorized by the License.
- M. The Licensee acknowledges that this License does not transfer any property interest in State tidal wetlands. This License allows the Licensee to use State tidal wetlands only for the structure or activity authorized herein and in no way limits the use of waters of the State by the public.
- N. This License is valid only for use by the Licensee. Permission for transfer of the License shall be obtained from the Water and Science Administration, Tidal Wetland Division. The terms and conditions of this License shall be binding on any assignee or successor in interest of the License.
- O. The Licensee shall allow representatives of the Maryland Department of the Environment to inspect the authorized activities.
- P. The Licensee shall notify the Maryland Department of the Environment, Water and Science Administration, Compliance Program at least 10 days before starting the authorized activities at (410) 901-4020.
- Q. The Licensee shall complete construction of the activity authorized under this License by the expiration date, otherwise a new General License shall be obtained.

R. Upon completion of the authorized activities, the Licensee shall notify the Maryland Department of the Environment, Water and Science Administration, Compliance Program at (410) 901-4020.



Dear Mr. Moulds:

This is in reference to your application, NAB-2023-60156-M53 (Kent County DPW/Bayside Landing Park), dated February 16, 2023, wherein you requested a Department of the Army (DA) authorization to remove approximately 725 linear feet (If) of existing deteriorated bulkhead; 3 pier structures; 20 finger piers; and 88 mooring piles. As part of reconfiguring the existing marina, construction of new structures and fill, all within an approximately 6,030 square feet (sf) area, is proposed as follows: construct approximately 725 If of bulkhead with 800 cubic yards of clean earthen backfill approximately 2.25-ft channelward of existing bulkhead; construct 2 piers (106-ft long by 6-ft wide and 151-ft long x 8-ft wide) and a total of 20 finger piers (15 to 20-ft long by 2-ft wide); and to install 88 mooring piles. One section of pier is proposed to be extended approximately 13-ft for safe access to the vessels, and to prevent accidental damage to the nearby boat ramp wingwall. No additional boat slips would be created from the extension of this pier. All work is located a maximum of 169-ft channelward of the approximate mean high water shoreline in Rock Hall Harbor located at 20927 Bayside Ave, in Rock Hall, Kent County, Maryland.

It has been determined that the activities authorized do not impair the usefulness of the USACE Navigation project and is not injurious to the public interest.

The United States Army Corps of Engineers, Baltimore District, has determined that the proposed work, if accomplished in accordance with the final approved plans is authorized as Activities a(4) Marina/Community Piers Reconfiguration and b(3) Bulkhead Repair or Replacement; Category B under the DA Maryland State Programmatic General Permit-6 (MDSPGP-6). This general permit was published in the Corps Special Public Notice #21-39 issued on September 30, 2021. This MDSPGP-6 verification is provided pursuant to Section 10 of the Rivers and Harbors Act of 1899 and Section 404 of the Clean Water Act. If any of the information contained in your application and/or plans is later found to be in error, the MDSPGP-6 authorization for your project may be modified, suspended, or revoked.

Your signature on the certification verifies your understanding that the work was completed in accordance with the terms and conditions associated with your DA permit.

Please be aware that the terms and conditions of this permit will continue to be binding on the new property owner(s) if structures or work authorized by this permit at the time of ownership transfer of the associated property. Although the construction period for work authorized by this MDSPGP-6 is finite, the permit itself, with its limitations, does not expire.
